

- The National CSR Hub at TISS also has a database/project proposal bank of prospective projects. Your organisation is eligible for applying for empanelment of a flagship project proposal. The National CSR Hub at TISS does not assure funding for empanelled partners, but plays a proactive role in connecting potential CSR funders with potential projects of empanelled partners through its project proposal bank.

The National CSR Hub at TISS, may also conduct field verification visits to empanelled organisations as a part of monitoring.
